INTRODUCTION TO THE EUROPEAN UNION -INTEGRATION HISTORY & INSTITUTIONS

Role and purpose of the class:

The precise and genuine character of the European Union (EU) has long been a point of contention in international politics. It is challenging to comprehend how to engage with and collaborate with an actor that is neither a traditional state nor an intergovernmental international body. While the EU wields considerable decision-making authority in some policy areas, it is powerless in others. This jumble of external relations competencies can be perplexing to non-members and strain ties between EU member states and the Union's supranational institutions. The lectures explore the intricacies of the EU's Foreign Policy, the identity issues surrounding the Community's existence and destiny, and touch on the EU's worldwide status and function, stressing the challenges the EU faces - with a particular emphasis on Russia-EU relations.

Title of the class:

POLITICS AND REGIONAL DEVELOPMENT IN CENTRAL EUROPE I-II.

Is the V4 the growth engine of Europe? Geoeconomic & Geopolitical challenges and Economic Dependencies

Lecturer responsible for this class: dr. habil Zoltán Gál, full professor

Role and purpose of the class:

This lecture examines economic divisions within the European Union (EU), focusing on the implications of global market reintegration and the EU accession of post-socialist states during their economic transition. These economic dependencies are analyzed through a historical and post-colonial lens, particularly in the context of Central and Eastern European Countries (CEECs), which occupy a semi-peripheral and intermediate (post)colonial position within the EU. The decline of the Foreign Direct Investment (FDI)-led growth model fuels discontent, economic nationalism, and anti-EU populism, exacerbated by recent geopolitical events like the Russia-Ukraine war and the US-China trade war. The central question is how Central and Eastern Europe (CEE) can adapt to the evolving global order, both economically and geopolitically. It also considers the impact of crises such as the COVID-19 pandemic, the war in Ukraine, trade disruptions, internal tensions within the Visegrad Group (V4), and the idiosyncrasies of the illiberal Hungarian regime with its unorthodox capitalist model. It aims to determine whether Hungary and the V4 group still serve as the "engine of Europe". The lecture also questions the enduring nature of intergovernmental cooperation within the Visegrad Group, with a focus on their economic achievements and disparities and underscores the importance of addressing these divergences and disparities within the V4 group. This research offers insight into evolving economic dynamics and geopolitical challenges within the EU, particularly concerning the CEECs and the Visegrad Group, in the context of the contemporary global landscape.
